PENALTIES:

- Penalties on arrears of taxes and on 2021 taxes remaining unpaid after October 29th, 2021, will be added at the rate of 1.00% per month, on the first day of each month.
- Arrears balance on your statement may not include all penalties to date. Please call the Municipal Office to confirm current balance.
- If you made the payment of arrears between June 14th, 2021 and the date of receiving your tax notice, your notice will not show the amount paid due to the printing process.
