## Tax Payment Information

### **DUE: OCTOBER 31<sup>st</sup>, 2025 AT 4:30 PM CDT**

- Payment represents the current calendar year's taxes, January 1<sup>st</sup> to December 31<sup>st</sup>.
- There are no discounts for early payment.
- We do not go by the postmarked date.

### **PENALTIES:**

- Penalties on past due amounts will be charged monthly interest on the first of each month at **1.25%**.
- Arrears balance on your statement may not include all penalties to date. Please call the Municipal Office to confirm current balance.
- If you made a payment of arrears after the tax statement was printed, the statement will not reflect the current balance. Please call the Municipal Office to confirm current balance.
