## The Sandy Lake

### Endowment Fund (SLEF)

is a non-profit organization. The purpose is to build an endowment fund and to create community investment capital for the betterment of the Sandy Lake community.

Each year, a portion of the fund's interest income can be distributed to successful project applicants. The principal portion of the fund will always remain with the fund. This provides long term support for new community projects.

The fund also provides opportunity for donors to consolidate their charitable giving and receive an income tax receipt. Contributions help build the fund and provide donors with a legacy supporting the betterment of the Sandy Lake area.

## Applying for Funding

Before application is made, projects should demonstrate physical evidence of having already started.

Funds requested must be directed to the purchase of capital assets, including repair or replacement of capital assets in the project. Funds cannot be used for consumption or operating costs of the project.

Consideration for approval excludes projects by formal education, religious, and political organizations.

Application intakes occur twice a year; June and December.
